

 - c. Confirmation of employment and indication of current position including an indication where you are currently placed/serving i.e. District, Circuit & School.
7. All completed application forms must be submitted with the required documents on or before the 30th of November 2017 to the respective district offices. Late submissions and incomplete applications will be disqualified.
